2 Structure, Governance and Management

2.1 Introduction

The 23rd Bromley (St. Augustine's) Scout Group was formed just before the outbreak of World War Two. Although a Scout Commissioner of that time said it all began in 1938, the first record we have is a note in a log book saying the first Scout meeting was held on 7th November 1939.

The Group is sponsored by the Church of England, St Augustine's Bromley Parish in the Diocese of Rochester. It is part of Bromley Scout District which in turn is part of the Greater London South East Scout County. It is registered with the Scout Association under registration number 10011744.

This Annual Report is issued by the trustees of the 23rd Bromley (St Augustine's) Scout Group in conformity with requirements of relevant Charities Acts and the Policy, Organisation and Rules of the Scout Association. It covers the financial year ended 31st March 2020 and the census year ending 31st January 2020.

2.2 Governing Document

The Group is established as a trust under rules which are common to all Scout Groups. The governing documents are those of the Scout Association, consisting of a Royal Charter which in turn gives authority to the byelaws of the Association and Policy, Organisation and Rules (POR) of the Scout Association. The Group constitution follows the model constitution set out in POR.

2.3 Management

The Group is managed by the Group Executive Committee, the members of which are the charity trustees of the Scout Group which is an educational charity. The trustees are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Committee consists of a Chairman, Treasurer and Secretary together with the Group Scout Leader, Assistant Group Scout Leader, and other members as appropriate. It meets at least three times per year.

The Group Executive Committee exists to support the Group Scout Leaders in meeting the responsibilities of the appointments and is responsible for:

- The maintenance of group property;
- The raising of funds and the administration of group finance;
- The insurance of persons, property and equipment;
- · Group public occasions;
- Assisting in the recruitment of leaders and other adult support;
- Appointing any sub-committees that may be required;
- Appointing Group Administrators and Advisers other than those who are elected.

3 Risk and Internal Control

The Group Executive Committee has identified the major risks to which they believe the Group is exposed. These have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

- Safeguarding. Keeping young people safe is a paramount responsibility of all adults in Scouting. The
 Group Administrator ensures that adults are checked through the Disclosure and Barring Service and the
 Scout Association's systems before appointment and that renewal takes place prior to expiry. All adults in
 the Group are required to complete the Scout Association Safeguarding Awareness Course. Young people
 are encouraged to raise any concerns that they may have affecting them or another member of the Group
 with a trusted adult and/or with their own parents or guardians.
- Injury to leaders, helpers, supporters and members. Risk Assessments are undertaken before all activities. The Group, through the capitation fees, contributes to the Scout Association's national accident insurance policy and takes out additional accident insurance for supporters (non-members).
- Reduction or loss of leaders. The group is reliant upon volunteers to run and administer the activities of the Group. If there were to be a reduction in the number of leaders to an unacceptable level in a particular section or the Group as a whole then there would have to be a contraction, consolidation or closure of a section. In the worst-case scenario this might necessitate closure of the Group.
- Reduction or loss of members. The Group provides activities for all young people aged 6 to 18. If there
 were to be a reduction in membership in a particular section or the Group as whole then there would have
 to be a contraction, consolidation or closure of a section. In the worst-case scenario this might necessitate
 closure of the Group.
- Reduced income from fundraising. The Group is reliant upon income from subscriptions, fundraising
 and ancillary sources such as hall hire. The Group holds reserve funds to ensure the continuity of activities
 should there be a major reduction in income. The Committee could raise the value of subscriptions to
 increase the income to the group on an ongoing basis, either temporarily or permanently. The current
 COVID-19 pandemic has resulted in the suspension of all face-to-face Scouting, fundraising activities and
 hall hire lettings. However, the Group has sufficient reserves to remain financially viable for the foreseeable
 future (see section 6.1 below).
- Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighbouring organisations such as the Church and other local Scout Groups. The Group has insurance cover in place to mitigate against permanent loss, and to compensate for the loss of income from hall hire to third parties arising from physical damage to the premises. (The insurance does not cover loss of hall hire income due to the current COVID-19 pandemic.)
- **Financial loss.** The Group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss; these include two signatories for all payments and comprehensive insurance to ensure that insurable risks are covered.

4 Objectives and Activities

4.1 Objectives

The objectives of a charity are set out in its governing document and therefore the objectives of the Group are as a unit of the Scout Association.

The aim of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local, national and international communities. The method of achieving the aim of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

4.2 Public Benefit

The Group meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.

5 Achievements and Performance

5.1 Development Plan

In the short term as with many others we face the challenges arising from the global Covid-19 pandemic, initially by ensuring a safe return to Scouting activities in accordance with National and District requirements. There will also be financial challenges as there has been a reduction in subscription income whilst Scouting activities have been suspended. In the short term we are highly likely to need to use some of our financial reserves to support a safe return to Scouting activities.

A further challenge we face as a Group, in common with many other Scout Groups, is complacency and resistance to change. For this reason, in 2011 the Scout Association published a vision for Groups to develop. The six key targets which we follow are:

- A Growing Group
- A Focused Group
- A Relevant Group
- A Youth Led Group
- A Sound Group
- A Diverse Group

In addition, we have a number of Group Sectional Assistants, Instructors, Group Executive Officers, a Group Scout Leader and Assistant Group Scout Leader. The total Group Membership as at the January 2020 census was 163.

5.3 Group Scout Leader Report

It seems quite a long time ago now but back in July 2019 we were delighted that six of our Explorer Scouts were able to attend the 24th World Scout Jamboree in West Virginia USA, a once-in-a-lifetime experience for them. This continued a long tradition of members of the 23rd Bromley being selected to attend World Scout Jamborees which is a testament to the strength of Scouting provided across the whole Group, from Beavers to Cubs to Scouts to Explorers.

After the Summer in the normal way as a Group we attended the local Remembrance Parade and for the second year one of our Scouts, Oliver Ward, sold chocolate poppies after the parade in aid of the Royal British Legion. Well done Oliver; it is really nice for the Group to be able to support other causes in our community.

In December we said goodbye to John Senior. John was Scout Leader at the 23rd when I joined in 1975 and he always remained a loyal supporter of the Group.

All the sections took part in the Christmas Fair and helped to raise £657 for group funds. The Christmas carol concert was well attended and the collection of £124 was donated to Bromley Brighter Beginnings, a local charity that works with vulnerable families.

2020 started as normal with the pantomime, Sleeping Beauty, which was well supported by the Sections.

We also received a donation of £4,363 from Sir Robert McAlpine for much needed new camping equipment. Sir Robert McAlpine was celebrating its 150th anniversary and was supporting causes in the community.

On March 17th, 2020, face to face Scouting was suspended because of coronavirus, but that did not stop us helping our community. A number of the leaders got together and delivered leaflets offering help and support for people who could not leave their homes or needed extra support at this very difficult time. We did weekly shopping, collected prescriptions and posted letters.

In June, as schools were preparing to return, we were pleased to be able to help a primary school by lending them our two big mess tents so that the children had shelter from sun and rain to eat their lunch and they were able to restart their education.

As we slowly started to come out of lockdown our thoughts turned to how we could restart our meetings, keeping everyone safe and following Government guidance. Scouting is working with the National Youth Agency and we are watching developments closely.

We wrote to all parents and carers in July and will share more detailed plans during the autumn term. We would encourage all parents and carers, young people and volunteers to raise concerns, ask questions and provide feedback. This can be done either via their section leaders or by email to gsl@23rdbromleyscouts.org.

In August we set our first monthly challenge for the whole Group. The challenges will be linked to activity badges, so everyone from Beavers to Explorers can take part. The first challenge is linked to the Hikes Away badge and more monthly challenges will follow.

As we come to the end of this very strange year, I would like to express my thanks to all the leaders and supporters who have continued to offer good quality Scouting for our young people. Sandra and I know it hasn't been easy, but we are very grateful for your continued support.

The Group Executive have still been working behind the scenes and our thanks also go to them. As always thanks go to Sandra Goodwin, Assistant Group Scout leader; her support is invaluable.

Finally, I hope we will be able to return to some resemblance of normal Scouting in the not too distant future. Until then, take care and stay safe.

Explorers - Phoenix Unit

The Explorer Unit have had over 35 Young People on our books throughout last year, making us one of the largest Explorer Units in Bromley! One of the more educational evenings we held was with the Metropolitan Police Road Safety Team – they came along with Virtual Reality headsets to show our Explorers the dangers of driving. Did you know that drivers aged 17-19 only make up 1.5% of UK licence holders, but are involved in 9% of fatal and serious crashes where they are the driver? With a number of our Explorers soon to be getting their own driving licences it was great for them to get first hand advice and an interactive activity about how to stay safe when driving.

We also had a great camp at Frylands in November, making use of some of the new camping equipment that the group were donated. Our successful year continued at the Bromley District Scouts of Steel Competition in March where one of our two teams was crowned Explorer Champions after posting the fastest time on the tough mudder style assault course.

We were proud to have three of our Explorers being awarded Jack Petchey Achievement Awards over the last year – they are aimed at recognising those who put in the effort and do their best. Each winner is awarded £250 for them to spend on an activity or equipment of their choice.

As with other sections, lockdown has been challenging but we have held a number of virtual meetings, many of which were organised by our Explorers. We had a quiz, a fun twist on Bingo and a scavenger hunt around the house!

After almost four years of helping run the Explorer Unit, Claire Pester has decided to step away from weekly

Explorer meetings so that she can spend some more time with her family. Claire will still be on hand to lend a hand when we need an extra leader, but a huge thank you must go to Claire for all that she has done to support the Unit over the years (we will certainly miss her ideas and suggestions of what to do on a Thursday night!).

5.8 Adult Recruitment Training

Welcome to our new leaders that have joined us this year. Robert Powell joined Hurricanes in May 2019. In September 2019 Laura Evans, Joe Tregent and Emily Kilby joined Spitfires. Joe and Emily have since gone to University so will only be available to help during the holidays. In September 2019 Marina Snook moved from Spitfires to Baloo and in September 2020 Alison Ancrum moved from Hurricanes to Spitfires.

We said thank you and goodbye to Stella Green in July 2019 and Paul Saunders in July 2020 for their many years of service as Leaders at the 23rd Bromley.

All our leaders at 23rd Bromley (St Augustine's) Scout Group have completed the required GDPR and safeguarding training modules to bring us in line with the new laws and Scout Association rules

5.9 Facilities

The Group Executive recognises its responsibilities with respect to Health and Safety within our headquarters building. To this end it is a regular agenda item at Executive meetings. Up until September 2020 a cleaner was employed to maintain hygienic standards within the building. Future arrangements are under consideration as the building remains closed at the present time. The fire extinguishers are tested on an annual basis by a third-party inspector and there is a regime of regularly testing the smoke alarms.

6 Financial Review

6.1 Reserves Policy

The Group's policy on reserves is to hold sufficient resources to continue its charitable activities should there be a shortfall in income and fundraising activities. We do not set out to make an annual surplus but aim to at least break even on day to day expenses and maintain sufficient funds over the longer term for the maintenance, repair and renewal of our equipment and assets and for capital investments in our premises. The Group held unrestricted reserves of £43,052 at the year-end together with restricted funds of £7,717 towards HQ refurbishment and equipment purchases. In total our monetary funds (i.e. cash and bank balances) at the financial year end stood at £50,769.

6.2 Investment Policy

The Group has adopted a low risk strategy to the investment of its funds. All funds are held in cash or instant access deposits using mainstream banks or building societies covered by the Financial Services Compensation Scheme. The Group Executive Committee regularly monitors the levels of bank balances and the interest rates received to ensure the Group obtains maximum value and income from its banking arrangements.

6.3 Fundraising

The Group is dependent upon membership subscriptions to fund its core activities and additional sources of income to support the membership and for the maintenance, renovation, refurbishment and replacement of buildings and equipment. All parents are encouraged to subscribe to Gift Aid to maximise the tax relief on subscriptions we can obtain through HM Revenue & Customs.

In addition to membership subscriptions the Group undertakes a number of fundraising activities throughout the year as set out at 5.7 above.

6.4 Assets and liabilities

In addition to the monetary assets shown in the balance sheet, representing cash and bank balances, the Group has non-monetary assets which are valued for insurance purposes at the amounts shown below.

Land and buildings £567,664

Contents, fixtures, fittings and stock £17,909

Scouting equipment £38,193

Land and buildings represent the HQ premises which are leased from St Augustine's Church in the Diocese of Rochester under an Insurance and Repairing lease whereby the Group enjoys beneficial use of the asset and bears the cost of insurance, maintenance and enhancement expenditure. The lease was renewed in 2016 and runs until 2045. The annual payments due under the lease are £10 until 2025, rising to £25 from 2025 and £50 from 2035.

Contents and stock primarily comprise furniture and fittings in the HQ premises as well as props, staging, sound and lighting equipment for pantomimes and gang shows. Much of the sound and lighting equipment was renewed during the year and this is shown under the purchases of equipment heading in the accounts.

As noted above we also purchased new camping equipment during the year using the donation received from Sir Robert McAlpine under their community grant scheme and we record our gratitude for their generosity.

6.5 Financial review

The accounts are presented below. Overall income and expenditure for 2019-20 are both lower compared to the previous year because the Group has not undertaken any major overseas expeditions during the year. The overall deficit for 2018-19 included expenditure on the Kenya trip for which the related fundraising income had been recognised in previous year's accounts. Such timing differences are a normal feature of receipts and payments accounting and excluding Kenya, the remainder of the Group's activities showed a net surplus of £8,783.39 (including donations) for 2018-19. The Group made a surplus of £1,893 for 2019-20 and remains in a strong financial position overall.

We have commenced fundraising for our HQ refurbishment project, details of which can be found on our website at https://23rdbromleyscouts.org/wordpress/hall/hqproject/. Monies raised are held in a restricted fund for the purpose which currently stands at £7,587.

In mid-March 2020, the coronavirus pandemic precipitated a country-wide lockdown which led to the suspension of all face-to-face Scouting activities nationally. As set out in the Group Scout Leader's report in section 5.3 above, as at the date of this report we have not resumed physical meetings. This is a contributory factor to petty cash balances held at the year-end being higher than normal because cash had been collected or withdrawn for activities in March which did not go ahead, such as the Legoland sleepover referred to in the Spitfire Beavers Section report.

The lockdown period has seen a reduction in our membership subscriptions, and we have deferred the forthcoming Christmas Fair, Pantomime and Gang Show in order to comply with regulations and best practice in respect of social distancing. These events normally provide us with a valuable source of fundraising income as well as being enjoyable activities for the Group and local community. We continue to incur the standing costs of maintaining our headquarters and contributing to Scout Association national overheads, so the Group is forecasting a deficit for the forthcoming financial year. Nevertheless, as noted in section 6.1 above, we have healthy financial reserves, so we do not foresee any short-term financial difficulties.

7 Conclusion

The past year has been another year of quality Scouting provided by all involved with the Group. We are extremely fortunate to have such a fantastic team of Leaders, Young Leaders, Executive Members and Adult Supporters who make it all happen for the young people. The year ahead brings challenges, but we are confident in our resilience and are guided by our Founder's motto, "be prepared."
